Dear Friends,

Thank you for your faithful prayers and support! Everything is moving forward, according to His divine plan! During our many years of experience in His service, we constantly observe that, **"God is faithful, by whom ye were called unto the fellowship of his Son Jesus Christ our Lord."** 1 Corinthians 1:9

We have just received a response from the FBI concerning our Criminal Background Checks. Once again, they cannot get a reading on either of us with their multi-million dollar machines, and have rejected our clearances following four complete months of the vetting process. You may remember that the authorities ran Ginger's prints a total of six times last furlough, and mine three times before we could leave the country. We used several 'old school' ink prints, digital prints, and 'modern' high tech methods; using three law enforcement agencies in Tennessee and Virginia, and a private tech company, in Maryland.

We will continue our efforts to contact an FBI agent who belongs to a Baptist Church, in Clarksburg, West Virginia. She intervened for us on our last 'go-round.' We also have met a contact at Crossroads Baptist Church, Washington DC. One of the church members is a Secret Service Agent who has offered to run our application through his office; and while visiting our son's church this weekend, a staff member said that their pastor could make an appeal through one of the Congressman. Who knows? We gave former Arkansas Governor Mike Huckabee one of our prayer cards recently, so maybe he could help expedite our return to South Africa through his office! **"Some trust in chariots, and some in horses: but we will remember the name of the LORD our God."** Psalm 20:7 Pray!

We sometimes feel like the Lone Ranger and Tonto! But, we are receiving some reports that others are having difficulties getting back to their countries as well. We will aggressively keep trying until we are in possession of this mandatory document. South Africa once accepted testimonies of state and local law-enforcement agencies. It was no problem to get the sheriff to write a letter for you, but now the FBI is the only agency recognized on the long list of requirements for volunteer visas.

We will keep you posted and encourage you to continue to pray for us! Special thanks to Pastor Neal and South Pointe Baptist Church, Anderson, South Carolina for their generous love gift. Appreciate all of you!
